



Discovery Card and Sunglass Hut terms and conditions

The following terms and conditions relate to the Sunglass Hut and Discovery Card promotion: Discovery Card holders can get up to 40% cash back at Sunglass Hut if they pay using their Discovery Card during June 2016. By participating in this promotion, cardholders agree to accept these terms and conditions.

Terms for the offer

- 1. The promoters are Discovery Card in association with FirstRand Bank Ltd and Sunglass Hut (the Promoters).
- 2. Discovery Card members agree to abide by these terms and conditions by participating in this promotion.
- 3. All information relating to this promotion and published on any promotional material will form part of the terms and conditions.
- 4. The promotion starts 1 June 2016 and ends close of business at 17:00 on 30 June 2016 respectively.

Who is eligible for the promotion?

- 5. Vitality members who have a Discovery Card who reside in South Africa, are 18 years and older, do not have a criminal record and his or her account is in good standing. Your account is in good standing if it is open, active and not in arrears for more than one month. Your account will be regarded as not being in good standing if you are undergoing debt counselling.
- 6. Discovery Card holders, who shop at participating Sunglass Hut stores in South Africa between 1 June 2016 to 30 June 2016 using their Discovery Card to pay in-store, will get up to 40% cash back, depending on their Vitality status and number of years on Vitality. All transactions made at Sunglass Hut during the promotional period, will be calculated and the double cash back will be paid once-off in August 2016.
- 7. Directors, partners, employees or agents of the promoter or any other person similarly connected are not eligible to enter.

Additional terms

8. You are advised to get your own tax advice regarding any benefit you may receive in terms of these rules. Discovery will not be responsible for any tax consequences.





- 9. If you want to purchase the products on behalf of another Vitality member, please note that we will only give cash back for Vitality members who are on your (the Discovery Card holder's) Vitality membership. We will not give cash back for Vitality members who are not on your membership.
- 10. Based on your Vitality status and number of years on Vitality, you normally get up to 20% cash back when you shop at Sunglass Hut. For this limited period, your cash back will be doubled. This means you can get up to 40% cash back when you pay for your purchases at Sunglass Hut using your Discovery Card between 1 June 2016 and 30 June 2016.
- 11. During this period the cash back is calculated in accordance with the normal rules and then doubled. After this period, the cash back will go back to the normal earnings. When the promotion ends, the maximum amount that you can get cash back on for Sunglass Hut, is limited to 20% of your total Discovery Card spend in that statement period. We apply a maximum limit of R10 000 spent at all Discovery Card partner stores when calculating your cash back. Please note that the maximum spend limit of R10 000 is not doubled.
- 12. When you buy goods from Sunglass Hut, you will be charged the full amount at the store. We will then pay your cash back into the primary cardholder's Discovery Card account in August 2016.
- 13. The Promoters reserve the right to revise, alter, cancel or amend the promotion rules (including any prize) with prior notice to all participants. Participants will waive and abandon any rights they may have against the Promoter, its affiliates or associated companies.
- 14. If required as a result of legislation or other legal reasons, the Promoters reserve the right to terminate this promotion immediately. In the event of such termination, all participants agree to waive any rights that they may have in terms of this promotion and acknowledge that they will have no recourse against the Promoters or their agents. The Promoters further reserve the right to terminate this promotion in the event that the promotion is held to be or becomes unlawful.
