

'Win a trip to Italy for four' Discovery Vitality competition: terms and conditions

The following terms and conditions relate to the Vitality 'Walk to win a trip to Italy' competition. By taking part in the competition, you agree to these terms and conditions.

- 1. The promoter is Discovery Vitality.
- 2. The competition will run until 7 August 2015.
- 3. The competition is open to all Discovery members 18 years old and older who live in in the Republic of South Africa.
- 4. This competition is not open to Discovery employees and their direct family members, directors, affiliates, employees of the promoters of Discovery or any other person who directly or indirectly controls or is controlled by Discovery.
- 5. All qualifying members must do all of the following:

If you are a Vitality member, simply:

- Visit Vitality's devices and apps page on the Discovery website
- If you haven't yet, link a fitness device or app to your Vitality account
- Track and upload at least one workout of 10 000 steps
- Earn a bonus entry each week by uploading another 10 000-step workout

If you're not a Vitality member, but have any other Discovery product:

- Log on to <u>www.discovery.co.za</u> and register as a Vitality guest
- Visit Vitality's devices and apps page
- Link a fitness device or app to your guest Vitality account
- Track and upload at least one workout of 10 000 steps
- Earn a bonus entry each week by uploading another 10 000-step workout!
- 6. All participants must use a device that links with Vitality and tracks step data.
- 7. Only one participant can win a guided walking holiday for four to the value of R195 000.
- 8. The prize includes a guided walking tour in Cinque Terre villages in Italy, return flights from Johannesburg to Italy with transfers to Cinque Terre, international travel insurance, seven nights' accommodation for four and Schengen visas.
- 9. The holiday prize **excludes any** domestic flights and domestic travel insurance to get to Johannesburg, meals not specified and personal items. These will be for the winner's account.
